# **DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Commissioner of the Manawatu District Licensing Committee pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012.

### **Application**

**FOUR BEGINNINGS LIMITED** has applied for the renewal of an off-licence in respect of premises situated at 42 Aorangi Street, Feilding and known as New World Feilding.

# **Inquiring Agency Reports**

#### **Police**

The New Zealand Police do not oppose the application.

#### Licensing Inspector

A report from the Manawatu District Council Licensing Inspector dated 28<sup>th</sup> July 2025 was received and considered. The Inspector did not oppose the application.

## **Medical Officer of Health**

The Medical Officer of Health does not oppose the application.

## **Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

## **Consideration of the application**

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012 by the Commissioner of the District Licensing Committee sitting alone.

In considering whether to renew the off-licence, the licensing committee considered the criteria set out in section 131 of the Act.

### **District Licensing Committee decision**

Having regard to the information supporting the application and having regard to the criteria set out in section 131 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the renewal of an off-licence to **FOUR BEGINNINGS LIMITED** in respect of premises situated at 42 Aorangi Street, Feilding and known as New World Feilding for a period of three years expiring on the 12<sup>th</sup> June 2028, subject to the following conditions:

- 1. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- 2. Alcohol may be sold only on the following days and during the following hours: **Monday to Sunday 7.00 a.m. to 10.00 p.m.**
- 3. No alcohol may be sold other than—
  - (i) beer that complies with the appropriate New Zealand food standard for beer; or
  - (ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - (iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - (iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - (v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- 4. The premises is undesignated.
- 5. The only area delineated on the attached plan dated 10 April2018 is a permitted area for the display and promotion of alcohol.
- 6. Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample.
- 7. Copy of this licence must be displayed at the principal entrance to the premises, the entrance from Aorangi Street is designated as the principal entrance.
