### **DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Manawatu District Licensing Committee pursuant to the provisions of the Sale and Supply of Alcohol Act 2012.

#### **Application**

**HIMATANGI BEACH BOWLING CLUB INCORPORATED** has applied for the renewal of an club-licence in respect of premises situated at 30 Ruanui Street, Himatangi Beach and known as Himatangi Beach Bowling Club.

#### **Inquiring Agency Reports**

##### ***Police***

The New Zealand Police do not oppose the application.

##### ***Licensing Inspector***

A report from the Manawatu District Council Licensing Inspector dated 24 July 2025 was received and considered. The Inspector did not oppose the application.

##### ***Medical Officer of Health***

The Medical Officer of Health does not oppose the application.

#### **Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

#### **Consideration of the application**

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered on the papers.

In considering whether to renew the club-licence, the licensing committee considered the criteria set out in section 131 of the Act.

#### **District Licensing Committee decision**

*Having regard to the information supporting the application and having regard to the criteria set out in section 131 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the renewal of an club-licence to **HIMATANGI BEACH BOWLING CLUB INCORPORATED** in respect of premises situated at 30 Ruanui Street, Himatangi Beach and known as Himatangi Beach Bowling Club, for a period of three years expiring on the 20<sup>th</sup> day of June 2028, subject to the following conditions:*

1. Alcohol must be sold only on the following days and during the following hours:  
**Sunday to Thursday 9.00 a.m. to 10.00 p.m.**  
**Friday and Saturday 9.00 a.m. to 12.00 midnight**
2. The club must have a secretary at all times.
3. Within 10 working days of the appointment of a new secretary, the secretary of the appropriate licensing committee is told the name of the new secretary.
4. The club licence must have available for consumption on the premises, at all times when the premises are open for the sale of alcohol, at reasonable prices, a reasonable range of non-alcoholic and low alcohol refreshments.
5. Food must be available for sale and consumption on the premises, in portions suitable for a single customer at reasonable prices and within a reasonable time of being ordered as follows:  
**A range of food choices must be readily available at all times. Menus must be visible and food should be actively promoted. A minimum of three (3) types of food should be available. The range or style of food will be as shown on any menu submitted.**
6. Drinking water must be freely available from the bar or kitchen and this must be clear to customers, while the premises are open for the sale and supply of alcohol.
7. Information relating to safe transport options must be readily available customers.
8. The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the responsible consumption of alcohol.
9. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.
