Application

District Licensing Committee decision

Having regard to the information supporting the application and having regard to the criteria set out in section 142 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the issue of a special licence to **5036 BOUTIQUE BREWS LTD** in respect of the events for which the licence was sought, subject to the following conditions:

- 1. Alcohol may be sold under the licence only on the following days and during the following hours: Saturday, 15 November 2025 8.30 a.m. to 4.30 p.m.
- 2. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:
 - Signage at the counter, staff to check ID, minors and intoxicated persons will not be sold alcohol.
- 5. Drinking water must be freely available at the exhibitor's site while it is open for business.
- 6. The volume of individual free sample tastings must not exceed 12ml of spirits.
