**DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Commissioner of the Manawatu District Licensing Committee pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012.

**Application**

**ELEMENTAL CIDER LIMITED** has applied for a special licence to provide alcohol sales. The application relates to the Cross Hill Gardens Country Fair 2025.

**Inquiring Agency Reports**

***Police***

The New Zealand Police do not oppose the application.

***Licensing Inspector***

A report from the Manawatu District Council Licensing Inspector dated 29 October 2025 was received and considered. The Inspector does not oppose the application.

***Medical Officer of Health***

The Medical Officer of Health does not oppose the application.

**Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

**Consideration of the application**

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012 by the Chairperson of the District Licensing Committee sitting alone.

In considering whether to issue a special licence, the licensing committee considered the criteria set out in section 142 of the Act.

**District Licensing Committee decision**

*Having regard to the information supporting the application and having regard to the criteria set out in section 142 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the issue of a special licence to **ELEMENTAL CIDER LIMITED** in respect of the events for which the licence was sought, subject to the following conditions:*

1. Alcohol may be sold under the licence only on the following days and during the following hours:  
**Saturday, 15 November 2025 – 8.30 a.m. to 4.30 p.m.**
2. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
4. Drinking water must be freely available at the exhibitor's site while it is open for business.
5. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed.  
**Signage at the counter, staff to check ID, minors and intoxicated persons will not be sold alcohol**
6. Samples of no larger than 30ml to be served in disposable plastic containers.

This licence is in force from **8.30 a.m. to 4.30 p.m., Saturday, 15 November 2025.**

2. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
4. Drinking water must be freely available at the exhibitor's site while it is open for business.
5. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed.  
**Signage at the counter, staff to check ID, minors and intoxicated persons will not be sold alcohol**
6. Samples of no larger than 30ml to be served in disposable plastic containers.
