# **DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Commissioner of the Manawatu District Licensing Committee pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012.

# **Application**

**FEILDING INDUSTRIAL AGRICULTURAL & PASTORAL ASSOCIATION** has applied for a special licence to provide alcohol sales. The application relates to three show jumping events.

## **Inquiring Agency Reports**

#### **Police**

The New Zealand Police do not oppose the application.

# **Licensing Inspector**

A report from the Manawatu District Council Licensing Inspector dated 9 September 2025 was received and considered. The Inspector does not oppose the application.

### **Medical Officer of Health**

The Medical Officer of Health does not oppose the application.

### **Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

# Consideration of the application

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012 by the Chairperson of the District Licensing Committee sitting alone.

In considering whether to issue a special licence, the licensing committee considered the criteria set out in section 142 of the Act.

## **District Licensing Committee decision**

Having regard to the information supporting the application and having regard to the criteria set out in section 142 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the issue of a special licence to **FEILDING INDUSTRIAL AGRICULTURAL & PASTORAL ASSOCIATION** in respect of the events for which the licence was sought, subject to the following conditions:

1. Alcohol may be sold under the licence only on the following days and during the following hours:

 Saturday, 20 September 2025
 4.00 p.m. to 10.00 p.m.

 Friday, 5 December 2025
 4.00 p.m. to 10.00 p.m.

 Saturday, 6 December 2025
 4.00 p.m. to 10.00 p.m.

 Saturday, 14 February 2026
 4.00 p.m. to 10.00 p.m.

- 2. The persons nominated to manage the sale and supply of alcohol at all times the premises are open for the sale and supply of alcohol is Jill Martin and a sign must be prominently displayed at the point of sale, which identifies by name the person responsible under the licence.
- 3. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
- 4. The following part of the premises must be designated as supervised Roped off area.
- 5. The licensee must ensure that no alcohol is taken from the fenced area as defined in the application.
- 6. The licensee must take the following other steps to ensure that the provisions of the Act relating to the sale of alcohol to prohibited person are observed:
  - Signage at the bar, staff to check ID, staff to monitor for minors and intoxicated persons, minors will not be served alcohol, intoxicated persons will not be served alcohol.
- 7. Food must be available for consumption on the premises during all times that alcohol is available for sale as follows:
  - BBQ steak, sausages, buns, and salads (or similar).
- 8. Water from the bar must be freely available to customers at all times when the premises are open for the sale and supply of alcohol.
- 9. Low-alcohol beverages must be available for sale and supply on the premises as follows: One type of low alcohol beer must be provided.
- 10. Non-alcohol beverages must be available for sale and supply on the premises including but not limited to orange juice and soft drinks.
- 11. A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed.

The Manawatu District Licensing Committee grants an exemption pursuant to section 213(2) of the Sale and Supply of Alcohol Act 2012 in respect of the appointment of a manager for the duration of this special licence.

# Duration

This licence is in force from **4.00 p.m.**, **Saturday 20 September 2025 to 10.00 p.m. Saturday, 14 February 2026** during the days and hours detailed in condition (1) above.
