

### SPECIAL LICENCE

Sections 22, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, Feilding Little Theatre Players Incorporated is authorised to sell and supply alcohol, on the premises situated at Feilding Little Theatre, 21 Stafford Street, Feilding 4702, to any person attending the following occasion or event (*or* series of occasions or events):

The Committee grants an exemption pursuant to section 213(2) of the Act in respect of the appointment of a manager for the duration of the Special Licence.

### **Conditions**

This licence is subject to the following conditions:


- 1. Alcohol may be sold under the licence only on the days and hours as detailed in the schedule attached to this special licence
- 2. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
- 3. The persons nominated to manage the sale and supply of alcohol at all times the premises are open for the sale and supply of alcohol is Elizabeth Evenson and a sign shall be prominently displayed at the point of sale, which identifies by name the person responsible under the licence.
- 4. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:
  - Signage at the bar, staff to check ID, staff to monitor for minors and intoxicated persons, minors will not be served alcohol, intoxicated persons will not be served alcohol.
- 5. Drinking water must be freely available at the bar and in the auditorium at all times alcohol is being sold.
- 6. Food must be available for consumption on the premises at all times alcohol is available for sale or supply as detailed in the application.
- 7. Non-alcohol beverages must be available for sale and supply on the premises including but not limited to ginger beer, soft drinks and orange juice.
- 8. Non-alcohol beverages must be available for sale and supply on the premises including but not limited to Amstel Light and DB Citrus.
- 9. The licensee must take the following steps to provide assistance with or information about alternative forms of transport from the premises:
  - Signage with access to a telephone at the ticket desk.

### **Duration:**

This licence is in force from 6.00 p.m., 18 July 2025 until 12.00 a.m. (midnight), 29 November 2025 during the days and hours detailed in the schedule included in condition (1) above.
