Application

- 3. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:
- 4. "Alcohol will not be served to minors", "No Id, No Service, No Exception" and "Alcohol will not be served to anyone intoxicated" signs must be displayed.
- 5. Drinking water must be freely available at the exhibitor's site while it is open for business.
- 6. The volume of individual free sample tastings must not exceed 10ml.
- 7. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
