- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:
 - Signage at the counter, staff to check ID, staff to monitor for minors and intoxicated persons, minors will not be served alcohol, intoxicated persons will not be served alcohol.
- 5. Drinking water must be freely available at all times when open for the sale and supply of alcohol.
- 6. Food, as detailed in the menu provided, must be available for consumption on the premises at all times alcohol is available for sale or supply.
- 7. Low-alcohol beverages must be available for sale and supply on the premises including but not limited to Heineken Light.
- 8. Non-alcohol beverages must be available for sale and supply on the premises including but not limited to juice, soft drinks and sparkling water.
- 9. A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed.
