### **DECISION OF THE MANAWATU DISTRICT LICENSING COMMITTEE (ON THE PAPERS)**

This application was considered by the Commissioner of the Manawatu District Licensing Committee pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012.

#### **Application**

**Makino Rotary Club Feilding** has applied for a special licence to provide alcohol sales. The application relates to **a fundraising evening to raise money for the Clubs charitable projects.**

#### **Inquiring Agency Reports**

##### ***Police***

The New Zealand Police do not oppose the application.

##### ***Licensing Inspector***

A report from the Manawatu District Council Licensing Inspector dated **24 April 2025** was received and considered. The Inspector does not oppose the application.

##### ***Medical Officer of Health***

The Medical Officer of Health does not oppose the application.

#### **Local Alcohol Policy**

There is no local alcohol policy in force within the Manawatu district.

#### **Consideration of the application**

As no objection to the application has been filed and no matters of opposition have been raised by the inquiring agencies, the application was considered pursuant to section 191(2) of the Sale and Supply of Alcohol Act 2012 by the Chairperson of the District Licensing Committee sitting alone.

In considering whether to issue a special licence, the licensing committee considered the criteria set out in section 142 of the Act.

#### **District Licensing Committee decision**

*Having regard to the information supporting the application and having regard to the criteria set out in section 142 of the Sale and Supply of Alcohol Act 2012 the Manawatu District Licensing Committee grants the issue of a special licence to Makino Rotary Club Feilding in respect of the events for which the licence was sought, subject to the following conditions:*

Having regard to the information supporting the application and the application meeting the relevant statutory criteria under section 142 of the Act I recommend the grant of a special licence subject to the following conditions:

1. Alcohol may be sold under the licence only on the following day and during the following hours:  
**Saturday, 10 May 2025 – 6.45 p.m. to 9.30 p.m.**
2. The licensee must display a copy of this special licence at the point of sale so as to be easily read by people attending the event.
3. Amanda Tull as the supervisor must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
4. The licensee must take the following steps to ensure that the provisions of this Act relating to the sale or supply of alcohol to prohibited persons are observed:  
**Signage at the counter, staff to check ID, staff to monitor for minors and intoxicated persons, minors will not be served alcohol, intoxicated persons will not be served alcohol.**
5. Drinking water must be freely available at all times when open for the sale and supply of alcohol.
6. Food must be available for consumption on the premises at all times alcohol is available for sale or supply as follows or similar:  
**Cheese platters, mixed platters of sandwiches and savouries, along with chips and dips**
7. Low-alcohol beverages must be available for sale and supply on the premises as follows:  
**One type of light beer must be provided**
8. Non-alcohol beverages must be available for sale and supply on the premises including but not limited to juice, soft drinks and sparkling water.
9. A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed.

#### **Duration**

This licence is in force from **Saturday, 10 May 2025 – 6.45 p.m. to 9.30 p.m.**
