4. Rangiwahia Community Plan

5. Domain Grazing Management

Fraser Martin discussed how the domain is currently managed. Those present agreed there were some unnecessary restrictions given the way the domain is used. It was agreed that as long as the domain was tidy and Fraser was aware of upcoming events, then Fraser could use his discretion around stock rotations. A sign will be added to the Domain gate advising that no dogs are allowed on the domain.

6. Feral animals

Bridget Murphy (via email) raised the issue of feral animals (cats) around the Church and village areas. This was discussed. Noted district wide issue. SB advised that the Community only has kill traps in the Reserve. GC advised he was trialling some traps on his farm. SDH advised that, in time, some pest traps may be available through the catchment group. It was recommended to contact the Regional Council to see if Bridget could borrow a trap off them.

7. Kitchen Sink and Cabinet

Discussion on removal of the single sink in the kitchen were had. HMc looked at the job. All agreed that if it was removed then it was just to be capped off in case it was hooked up again in future. Removal vs Non-removal was discussed.
