Council Update March 2025 – Rongotea

The second Council meeting for the year was held in the temporary venue at the St John building at 35 Bowen Street.

Jahle and Lei-lani Ponga spoke to Council about how the MDC grant helped them represent Manawatu at the U16 touch rugby national competition.

Councilor Bridget Bell gave a presentation to Council on her role with the Young Elected Members, an organisation for Councillors aged 40 years and under.
