# Council Update September 2025 – Rongotea

In the 7 August 2025 meeting, Council adopted the Manawatu District Growth Framework 2025. This document sets out Manawatu District Council's approach to growth over the next 30 years, in line with central government policy outlined in the National Policy Statement-Urban Development. (The Framework can be viewed in the Council Agenda for 7 August 2025, beginning on page 26)

In the 24 August 2025 meeting, Council received Annual Reports to 30 June 2025 from Feilding and District Promotions and Sport Manawatu, two organisations that have services contracts with Manawatu District Council. (The Annual Reports can be viewed in the Council Agenda for 24 August 2025, beginning on page 19 and page 40 respectively)

In this meeting, Council also adopted the Water Services Delivery Plan for approval for submission to the Department of Internal Affairs. The DIA and the National Transition Unit use the plans to monitor:

- Whether councils and entities are meeting transition milestones
- Whether risks to water service continuity are being addressed

As Manawatu District Council has adopted a stand-alone, in-house water services delivery model, it must submit a water services delivery plan by 3 September 2025, and every five years thereafter. (The Water Services Delivery Plan can be viewed as an attachment to the Council Agenda for 21 August 2025)

A draft version of the Water Services Delivery Plan was shared with the Department of Internal Affairs (DIA) for feedback in late June 2025. The DIA was generally supportive of Council's Draft Plan but requested more information in relation to financial ringfencing provisions and details of the asset renewal programme outside of Feilding. Amendments were made to the draft Water Services Delivery Plan based on this feedback.

If the Plan is rejected by the Secretary for Local Government it must be amended and re-submitted by a specified deadline. If the Plan is accepted by the Secretary of Local Government, MDC must then give effect to the content of the Plan. This has flow-on implications for MDC's annual and long-term planning, and bylaws.
