MDC has already invested in three waters infrastructure to a level that meets expectations of the community and central government. The cost of this investment is being met by MDC ratepayers whose rates are already higher as a consequence than some neighbouring councils who have under-invested in three waters.

If MDC merges it three waters activities with such councils, it seems almost certain that MDC ratepayers will be cross-subsidising ratepayers in other councils. Or, in other words, being asked to "pay twice" for good three waters infrastructure.

Option 2

I am also a ratepayer in Palmerston North and my inclination is always to support combined council initiatives where efficiencies / cost savings can be made.

However, this is subject to a fairness test for ratepayers.

PNCC has deferred making the required three waters investments and, as a consequence, would be looking for MDC ratepayers to cross-subsidise the investment required to bring PNCC infrastructure up to the required level.

Feilding ratepayers pay relatively high rates, largely because for at least 15 years MDC has been investing well in basic infrastructure, and especially water and wastewater. We have some stormwater issues but we also have \$22m in our long term plan to address these issues in Feilding and additional money for villages. In addition we are working well with Horizons who have \$15.5m to address flooding resilience in Feilding, and we hope to add considerably to this from the Regional Infrastructure Fund. Malcolm and I both serve on the Feilding Flood Resilience Governance Group which is a combined MDC/HRC group.

If MDC joined forces with PNCC, or Horowhenua, Kapiti and Palmy, what would happen is that Kapiti and Manawatu Districts would be heavily subsidising Horowhenua and Palmy who have major 3W infrastructure investments ahead of them. This is why Palmy and Horowhenua want to go with Kapiti and Manawatu, and Kapiti and Manawatu want to go alone in house.

During my 3 terms as an elected member for Manawatu District Council, we invested heavily into what is now referred to as the 3 waters space. Today we are now seeing the real benefits from this past investment funding through long-term loans and rate increases. The status quo is robust and sustainable for this district and has room for expansion. As part of the status quo, I would like to see further consideration for taking PNCC waste water and supplying fresh water as an income stream for this council and ratepayers it serves. We have paid a heavy price for our investment and strategic forward thinking and we are starting to see the dividends. Stable fresh water and sustainable treatment of waste water will be a strong currency in the future for this district.

Please tell us why you did not select the other two options as your preferred option.

The other options, while looking sustainable and attractive by combining services with other councils, may seem appropriate in the short, medium, and long term. However, when applied in the practical sense, we will see the cost of services increase across all the councils involved, and ultimately, the ratepayers in all councils pay far more than we do now. The concept of having a meter installed to your property and a separate bill is not appropriate given the already sizeable investment by current and previous sitting councils in this district. The massive regional elephant in the room is the current PNCC waste water plant that is no longer compliant or financially sustainable. It would be better that the Central Government (overseas investment fund) internally invests into this half-billion dollar project that the likes of PNCC now face. This is a clear warning and example to Local Government Councils that you can't 'kick the can' down the road when it comes to critical community infrastructure like 3 waters.

Please share any other feedback you have about water service delivery in the future.

I would encourage MDC to support PNCC if the concept of having to approach Central Government for internal funding for a new wastewater treatment plant is needed in the 'water done well' space. There also needs to be a large investment into stormwater networks across MDC before we start to see the real effects of projected climate change.

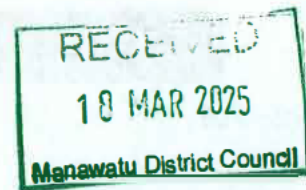

They will not be able to withstand the really heavy downpour of rain for several days. Some shops will be flooded as they have happened in the past. Sure - it will be an expensive programme to dig up the town road for pipe replacements. But do the job jointly with examining the power and gas pipes at the same time.

For new housing and commercial subdivisions the MDC does a great job of putting in large culverts and cooperating with other organisations for power and gas and optic fibre.

We have 3 water bores in the MDC rating area. Keep control over those bores for everybody in the MDC rating area.

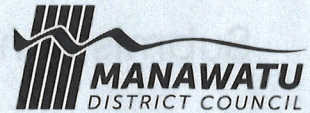

Rates need to be monitored carefully, and while water may become a 'charge', Council would have no control on how this may escalate while being run by an independent body (although general rates could drop and make you look good, there would also be the temptation to utilise that extra available debt on fripperies!)

While at present there might be a 'best' way to organise the three types of water, there are variations in how each Council handles these at present. Obviously MDC is running an above requirements system, but an overarching body may decide to standardise, and at a lower level which may mean maintenance could be minimised and current projects downgraded or cancelled.

Like other rural areas, Waituna West District occupiers organise their own drinking, waste and runoff waters – some better than others, relying on rain and groundwater and there is evidently no current requirement at this stage that this changes. There are a number of artesian bores within the Manawatu District for stock, irrigation and house water and these may need to be considered for a standard quality but more importantly for aquifer maintenance which can impact a large area. This may not be of Council concern at present but with oversight and maintenance of the rural water schemes an overarching water body would also probably take over this function as well which would impact all users of the schemes.

Why are Govt. levies of \$187,000 pa being charged? Is this to force Councils to join forces so that this will individually be less? It seems an extraordinary amount to be paying an office in Wellington just to think up ways on how to make the Provinces more difficult to live in!
