## **WHAKAPAPA / HISTORY**

*The Manawatū District is home to a number of Marae. In recognition of the important part they play within the community and because of a request from a Tangata Whenua Representative Group, Ngā Manu Tāiko Manawatū District Council (previously known as Marae Consultative Standing Committee) was established in 1998.*

*In 2015, Ngā Manu Tāiko Manawatū District Council established Te Kaunihera Working Group as a means of working through specific outcomes. This Working Group reports directly to Ngā Manu Tāiko Manawatū District Council.*

*The principal purpose of Ngā Manu Tāiko Manawatū District Council is to liaise between Council and local Tangata Whenua.*

*Ngā Manu Tāiko Manawatū District Council represents the interests of Tangata Whenua – the people of the land, as well as those with mana whenua status within the Manawatū District and is inclusive of all Māori in our community.*

*A continuing focus for Ngā Manu Tāiko Manawatū District Council will be to ensure:*

- *that all Māori of the district are represented*
- *that all Māori are able to contribute to Council decision making*
- *that Council is liaising with the people who have mana whenua*

*Membership of Ngā Manu Tāiko Manawatū District Council comprises one member from Aorangi, Kauwhata, Parewahawaha, Poupatate, Te Rangimarie, Taumata O Te Ra, Te Hiiri, Te Tikanga, Kotuku and Te Iwa Marae and the hapū of Ngāti Te Au and Ngāti Turanga, along with three elected members appointed by Council with the Chairperson being appointed by the Committee.*

#### NMT 19/228 ITEMS OF INTEREST

The Chairperson invited meeting attendees to share any items of interest, events or happenings for them over the past two months.

Councillor Alison Short – advised the Council had been successful in getting a Provincial Growth Fund grant towards the cost of a feasibility study into establishing

a regional resource recovery centre. She noted that she had met the new young Māori doctor at the Feilding Health Centre, who was a recent graduate from medical school. She also spoke about the dogs day out held at the Makino Aquatic Centre on Sunday 7 April 2019, where people could bring their dogs for a swim in the outdoor pool before it closed for the winter.

Richard Templer – talked about the union negotiations that took place today with the PSA. Of interest was that the meeting was opened with karakia and waiata and the first part of the meeting was conducted in te Reo. The negotiations concluded with waiata and karakia.

Councillor Stuart Campbell – spoke about the recent submissions on the proposed priority thoroughfares, and noted that Council would be further considering that item in the near future. He spoke about the Community Funding Committee that Councillor Short, himself and other committee members spent most of today in. This meeting gave out grants for community development activities, events and representative activities.

Kipa Arapere– advised there would be a hui rangitahi at Poupatate Marae this weekend, starting Friday evening and ending Sunday afternoon.

Manurere Devonshire – no update for Taumata o Te Ra Marae but noted the good turnout for the recent We Are One Civic service in support of Christchurch.

Oriana Paewai – the Feilding Health Centre was doing work around equity and access for Māori to services, and noted they were looking at recruiting more doctors.

Ted Devonshire – noted he would be replacing Robyn Devonshire as representative at Ngā Manu Taiko Manawatū District Council for Te Au.

Peter Reweti – at Tikanga Marae they were rebuilding their gardens. He invited anyone that was interested in putting in gardens at their marae to visit and get some ideas from the work they were doing.

Amiria Arapere – spoke about the kaupapa whakaoranga marae, which was about how to cope in a disaster from a marae point of view. She advised that they had a visit from a group from Kawerau that talked about their experiences from when they had an earthquake a few years ago and were not prepared, and the difference made by having relationships and plans in place when they experienced a flooding disaster recently.

Wiremu Te Awe Awe – spoke about the flooding they experienced at Te Rangimarie Marae in 2015 and the time it took to get their marae up and running after that. He spoke about the recent Sister Cities Conference in Palmerston North and the noho marae that was held for delegates at Te Rangimarie Marae. He spoke about the importance of visitors coming to marae and having a cultural experience, and the barriers this breaks down.

Trieste Te Awe Awe – spoke about the completion of facilities at Te Rangimarie Marae that were finished in time for the Sister Cities Conference. At the moment they were putting in a barbecue area that would be covered in. Down at the awa they had a beach area, and the river had been cleaned out.

**NMT 19/234 UPDATE ON THE COUNCIL BYLAW REVIEW**

Report of the General Manager – Community and Strategy dated 13 March 2019 that provided Ngā Manu Tāiko Manawatū District Council an overview of the key changes Council was proposing to make to those bylaws that were of greatest interest to them, provided copies of the draft Cemeteries Bylaw and Administration Manual, the draft combined Drainage and Trade Wastes Bylaw and the draft Water Supply Bylaw for consideration and feedback, and provided an update on progress with the cultural significance assessments of freedom camping sites. Once completed, the Site Assessment would inform recommended changes to the Freedom Camping Bylaw.

It was noted this was an early stage of the project, so would not be the only opportunity to give feedback. It was proposed to notify the first bylaw in June for public consultation and submissions could be made then. Hearings were scheduled for 19 August 2019.

#### NMT 19/235 PRINCIPAL ADVISER MĀORI - PROGRESS REPORT

Rārite Mātaki, Council's Principal Adviser – Māori sought advice and guidance from members on navigating sensitivities around engaging appropriately for discussions where there may be matters that need careful handling.

It was agreed he would bring this kaupapa to the next Te Kaunihera Working Group hui for discussion.

#### NMT 19/236 PRESENTATION - KIWIRAIL

Representatives from KiwiRail Britton Broun, Senior Government Relations Manager, Simone Hadley, Project Lead, Thomo Thompson, Iwi Liaison Manager and Logan Kahui local representative from KiwiRail's Māori Network Te Kupenga Mahi, spoke about proposals for a new freight hub near Palmerston North.

Simone Hadley spoke about the reasons this area was important to them and why they have a focus on the Palmerston North region for their growth. She gave an overview of the process they would be following and how they saw it working.

She outlined the positive regional impacts that they perceive coming from the proposed relocation of the freight hub. For them as an organisation, they have not had the opportunity of building something new in a new age, that could take advantage of new technologies. Since the last freight hub was built in approximately 1963 there have been a lot of changes in the way that freight is moved.

She spoke about the stages for this project:

- Stage one – develop a master plan for a future proof freight hub
- Stage two – multi-criteria analysis of where the hub would fit to decide on a preferred site
- Stage three – statutory process

- Stage four – purchasing the site, then design and build.

Simone Hadley advised they would be providing information on their website and seeking feedback.

The following discussions arose from questions asked:

- Preliminary thought on the location of the freight hub has not been given as they did not want to prejudice the process – will be working out first what they want to build, then would look at where that would best fit in;
- With regard to representation on the Regional Land Transport Committee at Horizons Regional Council, KiwiRail were going through a review of how rail fits with land transport and having discussions with organisations such as NZTA, Accelerate 25 and the Regional Council to get the right outcome for the region;
- With regard to effects on Aorangi Marae from proposed regional ring road and the rail corridor, with rail affecting access to the urupa and concerns about the noise impact from volume of traffic and trains, it was noted that KiwiRail would need to engage early on to discuss safety concerns that impact on the marae;
- Impact of logging operations in the Manawatū District and opportunity to provide better transportation options for logs;
- Development of shared walkway / cycleway between Palmerston North and Feilding which may need to go beside the rail corridor. Also Te Araroa walking trail that has a section of the walkway on Campbell Road opposite Aorangi Marae – opportunity to consider these factors when looking at the wider project;
- Noted Whanganui Rail Yards were not part of this project;
- Increased interest in KiwiRail tourism and what can be seen from rail carriages as they pass through the Manawatu district;
- Noted it was too early to quantify the number of new jobs that could be generated from this project;
- Noted the biggest barrier to this development would be not receiving funding for the next stage. They were working hard on how this would work and what exactly was needed, and there was a desire from the KiwiRail perspective to make this happen;
- noted that environmental studies were being undertaken as part of the process, in line with Resource Management Act 1991 requirements. KiwiRail spoke about the importance of making direct links to how the new freight hub would be valuable and meaningful to the communities along with building relationships with iwi and hapu groups.

The Chairperson thanked the representatives from KiwiRail for providing their update on this project, and noted the committee looked forward to further updates in the future.

#### NMT 19/237 REPORT BACK FROM TE KAUNIHHERA WORKING GROUP

Te Kaunihera Working Group met during March with their discussions including the following matters:

- Resource Management Act training available through Horizons Regional Council;
- Community Development Strategy and the proposal to align the strategy with Te Whare Tapa Whā principles;
- Freedom Camping prohibited areas, and restricted areas within the district;
- Provision of guidelines and terms of reference for new members in the new triennium.

The Chairperson noted that the public consultation on the proposed Community Development Strategy had been brought forward to 21 June 2019, with hearings for submissions scheduled for 8 August 2019.

It was advised that there would be a new representative from Te Rangimarie Marae for future Te Kaunihera Working Group hui as the previous representative was not now able to attend. Contact details would be forwarded to the relevant Council officers for noting.

#### NMT 19/238 DISCUSSION POINT – ANNUAL PLAN 2019-20

It was noted that because there were no significant variations to be made to the plan from what was set out in Year 2 of the Long Term Plan 2018-28, there would not be any formal community consultation on the 2019-20 Annual Plan prior to its adoption.

The Council formally adopted the 2019-20 Annual Plan at its meeting on 21 March 2019.

Prior to adoption it was agreed by the Council that it would provide information to the community regarding the content of the plan as well as an opportunity for community groups to seek the support of Council for community initiatives.

Copies of the Council's brochure "Community Funding" were circulated to members of Ngā Manu Tāiko Manawatū District Council. The brochure outlines Council funds available for community initiatives, and explains the process for those who may have planned to make a submission for funding to the 2019-20 Annual Plan.
