Thanks very much for all this work. I've got a few edits (most arising out of previous errors at our end):

### **Voting Documents (all)**

- Add the hyphenated 'ū' in Manawatū District Council right at the top
- Add the hyphenated 'ā' in Mātangi (Ngā Tapuae o **Mātangi** Māori Ward)

### **Rural Ward Voting Document**

- Remove Grant Hadfield's middle name – this was accidently included in the "show on voting paper" name field when we loaded the nomination via the portal, but I've double checked his nomination form and he only wants "Grant Hadfield"
- Add a full stop after "Lower Rates" in the affiliation for Jerry Pickford. It's only noticeable because he comes after Aaron McLeod who has the full stop included

### **Māori Ward Voting Document**

- Add the hyphenated 'ā' in Mātangi (on the second page)

### **Candidate Booklet**

- Orange Bin edits (pages 2 – 4):
  - Could we add "(and 9.00am to 12.00pm on Sat 11 October)" to the Manawatū District Council one (third in the list), and move this to the top of the list?
  - Several times need to be written in full (e.g., 9.00am instead of 9am)
  - Feilding & District Promotion: 9.00 am to 4.30 **pm** (instead of 4.30 am)
  - Amend several location closing times for Saturdays from 12 pm to 11.45 am (as its 11.45 am on Sat 11<sup>th</sup>). I don't want anyone to leave it to 11.56 (etc) on Sat 11<sup>th</sup> and be out of luck, so would rather indicate that the closing time for Saturday's is always 11.45 am. For these ones:
    - Feilding Health Care
    - Resene Colourshop
    - W Amey and Co
- Candidates:
  - Remove Grant's middle name
  - Add a full stop after "Lower Rates" in the affiliation for Jerry Pickford
  - Show Clive Raharuhi's principle place of residence as **not** being within the Feilding General Ward area

I've double checked all the photos and profile statements – all look correct (aside from above edits).
