Hi we are currently undertaking a review of Pukepuke Lagoon and the potential impact the drainage scheme is having. To help with this review is it possible to get the following information:

- Pukepuke Lagoon water quality
- Pukepuke Lagoon outlet water quality
- Pukepuke Lagoon inlet water quality
- Groundwater quality from any adjacent shallow monitoring bores
- Groundwater levels from these bores
- Any ecological assessments
- Any reports especially ones that relate to the predominant water source.

Once we have collated the information we would be keen to meet to discuss the findings and potential recommendations.

We are aware that there is information on Lawa and will be reviewing this information as well.
